Through these summer school programmes, the students are motivated to enroll and attend the different courses offered by them and to engage with leading-edge faculty at one of the world's best universities, situated in the heart of London.

Rules and regulations for attending the summer school programme:

- St. Joseph's College of Commerce only encourages and motivates its students to take up these summer school courses. The institution is neither responsible for conducting nor is it responsible for arranging the courses for the students.
- The students can enroll for this programme only after getting approval in writing from the Principal. Only those students who satisfy the eligibility criteria decided by the management will qualify for the same.
- The complete registration process, attending the course, arranging for accommodation, travel, visas and any other matter related to the same is the sole responsibility of the student.
- The College will consider the attendance for the students attending the

programme only on the submission of the certificate provided by LSE on completion of the course and exams conducted by them.

- Only one day leave before and one day leave after in addition to the three weeks of the course of study will be considered for the same.
- No additional classes will be conducted by St. Joseph's College of Commerce for the students who miss them on account of attending the programme.
- It is the responsibility of the students to complete all the CIA components conducted by the respective teachers during the period of study abroad.
- The students are only allowed to register for the 1st and 2nd session courses as the 3rd session clashes with the mid semester examination conducted by the College.
- St. Joseph's College of Commerce is not responsible for any liability of the above programme and it is completely the parents and students risk and responsibility to apply for the same.
- The Principal's decision on any matter is final and binding.
